



Utah Regulators Take Down Kent Valley Selects 7 to 2 in Game Two at Nationals

Gilmour Arena, Gates Mills, OH – KVHA News for 31 March, 2011 – The Kent Valley Selects faced a tough Utah Regulators team this morning in game two of the USA Hockey Bantam Tier-II U18 Tournament. The Regulators scored five unanswered goals on the Selects before Buck Scougale and Johnny Scherer each scored goals in the closing minutes of the second period. Scougale’s goal, a power play goal, was assisted by Wyatt Duncan and Kale Pokrzywinski. Scherer’s goal was assisted by Caleb Bromley and Buck Scougale. The Regulators added two more goals in the third period for a final score of 7 to 2.

Both teams took a large number of penalties. Kent Valley had 3 minor penalties in the first period, 3 in the second and 6 in the third for a total of 12 penalties. The Regulators had 4 minor penalties in the first period, 3 in the second and 3 in the third for a total of 10 penalties. The Selects were able to convert one of their second period power plays for a goal and they were able to kill all of the Regulators’ 12 power play opportunities.
